# Board Minutes

#### June 11, 2023

G.B. Washburn called the meeting to order. Pastor Scott Oliver had our opening prayer. Minutes were reviewed. Vivian Doyle made a motion to approve the minutes and Kay Boyd seconded, the motion carried.

Treasurer's Report – Bud Hippisley was unable to attend the meeting and sent the Treasurer's report to G.B. G.B. presented the treasurer's report. There were four offerings in May with \$4,896 donated and \$25.00 donated for the Backpack Program. Expenses for the month were \$13,559. Beyond normal expenses were \$8,259 for the AC repair and \$1,049 for food and clothing for the Backpack Program. \$571 was collected and distributed for the Pentecost offering. Total expenses were \$14,608. The final figure from the yard sale is not available yet, but it's estimated to be about \$700.00. Kay made a motion to approve the treasurer's report and Joyce Ingram seconded, the motion carried.

#### Pastor Report -

- Pastor Scott will be here Sunday June 17<sup>th</sup> and will be gone June 19<sup>th</sup>-26<sup>th</sup>, taking classes at Lexington Theological Seminary in KY. He will be back in the office on Wednesday June 28<sup>th</sup>. Bob Mooty will be the guest preacher on Sunday, June 25<sup>th</sup>.
- Vacation Bible School (VBS) is scheduled for Sunday July 9- Thursday July 13<sup>th</sup>. We need volunteers to help with the program
- Homecoming is scheduled for July 9<sup>th</sup>. Pastor Scott is expecting to have the invitations out by the end of this week. Cleanup day will be scheduled on July 8<sup>th</sup>.
- Question was raised, do we hold a Board meeting in July since it would be on the same Sunday as Homecoming? After discussion, Joyce made a motion to cancel the July Board meeting, and Kay seconded, the motion carried.

#### **Committee Reports**

#### **Old business**

- Mark Woody's offer to put up crosses on the church property. This possibility was discussed at the recent Elder's meeting. The Elder's agreed that there is not a location on the church property that will offer good visibility of the crosses without interfering with visibility of church features. Joyce made a motion to decline Mark Woodie's offer to in
- stall crosses at the church and Kay seconded, the motion carried.

#### **New Business**

- Father's Day –We will have candy favors for Father's Day.
- Homecoming See Pastor's Report. We need arrange for the meal for after the homecoming service
- VBS See Pastor's Report
- Question was raised, what is the status of the graveyard situation? No one has contacted GB since last November about transferring ownership of the graveyard. He is waiting to hear from the Prillaman family or their attorney. GB's concern is the upkeep of the graveyard; right now, it's being mowed only twice a month.

Pastor Scott had a closing prayer, Meeting adjourned.

# Board Minutes

#### **August 13, 2023**

G.B. Washburn called the meeting to order. Pastor Scott Oliver had our opening prayer. Minutes were reviewed and amended to correct the misspelling of the Prillaman name. Joyce Ingram made a motion to approve the amended minutes, Vivian Doyle seconded, the motion carried.

Treasurer's Report – Bud Hippisley reported for June and July. The expenses for both months were normal. The electric bill for the Church is way down from the past few months. Typically, about \$160 of the utility bill is for phone and internet. The electric bill in June and July was under \$200 and had been running about \$450 in April and May. The monthly allotment for insurance increased from \$326 to \$381 in July; this is a 17% increase. With recent natural disasters, we can expect insurance to continue to increase. Question was asked about the about the increase in Backpack Program expenses. These are due to additional students in the program and school supplies purchased in preparation for back to school. Vivian made a motion to approve the Treasurer's Report, Barbara Smith second, the motion carried.

#### Pastor Report -

- Thank you for allowing my attendance at the General Assembly. I attended workshops and meetings on July 31<sup>st</sup> and August 1<sup>st</sup>. Major newsworthy events that occurred:
  - The General Minister and President, Terri Hord Owens, was reelected for a second and final eight-year term.
  - The Covenant Project, an initiative begun in 2019 undertaken by the Governance Board aimed at seeing how we can live in covenant within our congregation and other Disciple Churches was discussed.
  - A resolution was adopted in association with the Covenant Project, which will result in several administrative changes, most notable: 1) a change in structure and focus of the General Board, 2) a move to using technology to facilitate more frequent and increased communication between local churches and the board, and 3) scheduling the General Assembly on a three-year instead of a two-year cycle.
- In accordance with this, I am trying to gauge interest in an adult Sunday School class focused on some of the theological underpinnings of the Disciples of Christ.
- I have been named Moderator-elect/Vice Moderator to the District. After a pause in
  District meetings due to Covid, Marilyn Whittaker, the current Moderator, and I are working to revamp and restructure the District to adapt to the changing situations in the
  churches in the area.

We need to pay our dues to the District

#### **Committee Reports**

• Property: Joyce Ingram reported that we need to purchase a leaf blower for the Church; one was needed during the Church clean up. There was discussion of whether or not we should purchase gas or electric? Since a battery operated electric one can be stored inside the Church, this was the favored option. Vivian asked if we need a weed eater? If so, it should be the same brand as the leaf blower so the same battery can be used. GB will look into pricing a battery-operated leaf blower.

#### **Old business**

- Homecoming: GB said Homecoming went really well. We didn't have a lot of meat for the meal, but there were plenty of sides. Joyce said the Church needs to consider purchasing chicken when we host a pot luck.
- VBS: Pastor Scott said VBS went really well. It's our turn to host next year. Since we
  will have a lot of guests attending VBS, we take care of some maintenance items
  around the Church, like the door downstairs near the nursery that sticks.

#### **New Business**

- Pump House: Someone ran into the old pump house and destroyed the building. A plumber came and installed a new pressure tank for \$1,300. The State Police are investigating and have a possible lead. We don't know if charges will be made or if the person has insurance. We need to determine if both the well and the well house are on the Church property or if the well house is on the Lodge property. If the well house is on the Lodge property, they will split insurance cost with us. The Lodge is considering putting the pressure tank inside the basement of the Lodge rather than restoring the pump house, possibly because they consider it an eye sore or to prevent another accident. This raised concerns about water pressure to the Church and led to discussion of possibly putting a pressure tank in the Church basement with controls in the lodge. Additionally, the Lodge wants to put a manhole cover over the well. Since the well in under the parking lot, this will require digging up the asphalt. The Lodge thinks they have people that can do much of the work to put a manhole cover in for the well.
- Custodial Services Kay Boyd is resigning as Custodian of the Church. Options are to have a list of volunteers rotating to clean or to hire another person. Consensus was to advertise to the congregation to see who may be interested in the position. GB will compose an email and send to Pastor Scott to send out.
- October Breakfast Debbie Haynes announced a breakfast to be held on Saturday, October 7<sup>th</sup> with proceeds to go to the Backpack program. Del Smith prepared a brochure to advertise for the breakfast.

- The Finance Committee met the last couple of weeks to discuss the low rate of interest we are drawing on CDs at the bank. We have approximately \$65K in CDs at the bank maturing in 2026, earning 0.4% interest. The Disciples of Christ Foundation have socially conscious mutual funds available at rates of 5% or 6% interest and have been at that level or higher over the past few years. Administrative cost of these mutual funds is 0.5%. In all our funds we have about \$150K. The Finance Committee would like to take all but \$25K to invest in mutual funds to yield as much return on the Church's investment as possible with low risk. We request the Board give the Finance Committee permission to invest the funds to earn more. Curtis Washburn made a motion to allow the Finance Committee to invest the finances of the Church in Disciples of Christ mutual funds, retaining \$25K as liquid funds for emergency use, and to report back to the Church semi-annually, Joyce Ingram seconded, the motion carried.
- Snow Creek Times Sept Nov: Barbara Smith is preparing items for the next issue and needs them by Tuesday, August 15. So far, she has: the October Breakfast, Trunk or Treat, and highlights from Homecoming.

Vivian made a motion for the meeting to be adjourned.

Pastor Scott said a closing prayer. Meeting adjourned.
