# Board Minutes

## Snow Creek Christian Church Board Meeting - September 10, 2023

G.B. Washburn called the meeting to order. Pastor Scott Oliver had our opening prayer. The August minutes were reviewed. Joyce Ingram made a motion to approve the amended minutes, Vivian Doyle seconded, the motion carried.

Treasurer's Report - Bud Hippisley reported for August; it was a reasonably normal month. The only unusual expense was \$1,237.00 for the plumber to repair the line and demo the pump house. Again, the new monthly number for insurance is up 17% to \$381 and will remain at this rate for the next 10 or 11 months. The Backpack offering at end of July should have been in July report, but did not get deposited until August so it is on this report. Bud has spoken to Church Mutual and notified them that we will not have a claim for the well or the pump house since we now know they are on the Lodge property, not church property. Curtis Washburn made a motion to approve the Treasurer's Report, Vivian second, the motion carried.

**Committee Reports:** No reports

#### Old business

- Well House- There is no information from the State Police yet on who may have hit the
  pump house. The Lodge is working on estimates for repair and will submit to their
  insurance company. They are still planning to install the tank in their basement. We will
  continue to monitor their progress and decision, since it impacts our water service.
- Finance Committee In August, the Board approved a motion to allow the Finance
  Committee to invest church funds in the Disciples of Christ Foundation mutual funds. The
  Foundation requires a Resolution by the Board before funds can be invested in their
  products. The Board needs to complete a certificate of authority/signature card. Bud
  Hippisley made a motion to complete the certificate of authority signifying the Board's
  Resolution to invest funds in the Disciples of Christ Foundation products in accordance with
  the Board's August decision, Joyce seconded, the motion carried. (See attached copy of
  certificate of authority.)

### **New Business**

• Custodial Services - GB received three bids for the custodial position:. Veronica Doyle, Lonnie Fredette, and Kimberly White. Veronica is a member and has been performing the service temporarily since Kay Boyd had to stop. GB met with Kimberly, Veronica, and Lonnie walked them through the church and explained the required service. Question: Do we need to have these people bonded? Answer: We haven't in the past, but have had them contracted,

which should protect our interest. Two clause additions are required to be added to the contract: 1) the contractor must give 30 days' notice of intent to leave the position and 2) the contractor is responsible for finding an acceptable substitute when they are ill or on vacation and cannot perform the duties. Bud moved that we contract with Veronica Doyle for custodial service, based on her training from Kay and her membership in the church, Vivian seconded, the motion carried.

Nomination Committee - GB asked for people to let him know if they are willing to work on the Nominations Committee. Last year, Bud Hippisley, Linda Hippisley and Barb Smith were on the committee; GB will contact them to see if they are willing to serve again this year..

Purchase Vacuum Cleaner- GB recommended a vacuum cleaner be purchased so that *one* can be available upstairs and one downstairs to make cleaning the 'church easier. It should have attachments that can be used to vacuum the cloth seats in pews. For future discussion he recommends the Board consider purchase of a storage cabinet for cleaning supplies and vacuum so these supplies can be removed from the kitchen and replacement or maintenance of problematic electrical outlets. Joyce moved to spend up to \$200.00 to purchase a new upright vacuum cleaner, Vivian seconded, the motion carried.

#### Schedule:

- Piedinont Community Services
  - At the end of July Pastor Scott received an email from local community service board that provides mental health services for people With addictions. They have invested in a mobile unit that will be used to make care more accessible to people in the community, since transportation to their offices is a problem for many participants. The concept is for the unit to set up for a day (8:00 AM =5:00 PM) in different locations in Patrick, Henry and Franklin Counties on a rotating basis to service individuals in that area. The organization contacted Pastor Scott inquiring about Snow Creek Church as a potential spot for the mobile Unit due to its strategic location on a main road and closeness to the intersection of Sontag Road and Snow Creek Road. In addition to parking in the church lot, they have asked for access to a room for group counseling sessions. Pastor Scott has spoken to the Elders about this request.
  - O Cynthia Shively (Nurse Practitioner) and Tammy Franklin (Admin Associate) from Piedmont Community Services came near the end of the meeting and spoke with Board, provided them with an introductory letter about the program and gave a tour of the mobile unit.
  - Their goal is to increase access to treatment in Patrick, Henry and Franklin Counties and was funded through grants. The unit is self-sufficient with a generator and bathroom and is equipped for administrative intake of individuals, peer counseling and assessment of physical health. While a nurse practitioner will be on board and can prescribe medication no medication, other than NARCAN, will be stored on the mobile unit.
  - o If, the Board decides to move forward with this request, a Memorandum of;

'Understanding will be established between the church and Piedmont Community Services. They have secured agreements with several locations already.


GB said that the Board would not make a decision before the meeting. He also recommended that they contact the Snow Creek Rescue Squad as a potential location, since it has a paramedic on duty during day time hours.

GB made a motion for the meeting to be adjourned. Pas-

tor Scott said a closing prayer. Meeting adjourned. Re-

#### Ruth Belcher Davidson


