Board Minutes

Board Meeting - June 09, 2024

G.B. Washburn called the meeting to order. Pastor Scott had our opening prayer. The May meeting minutes were reviewed. Joyce Ingram made a motion to approve the minutes, Linda Hippisley seconded, the motion carried.

Treasurer's Report – Bud Hippisley reported for May; May was a big month for expenses due to paying half of the roof cost, \$32,800; the balance will be paid in June. Disposition of the steeple remains to be determined. General donations were good, the net on the breakfast was about \$750, and we had the Pentecost Offering and Memorial Donations for Kay Boyd. Other than the roof, there were typical expenses in all categories. Insurance cost will go up 38% starting next month. Under services, we had the fire extinguisher inspection. This cost doubled last year due to some extinguishers needing replacement. The invoice doubled again this year. Bud checked with the company, who said there was a problem with their software and adjusted the bill down appropriately. Vivian Doyle volunteered to contact the Fire Marshall to see if there is a more economical way to maintain and inspect our fire extinguishers. Janet Purdue made a motion to approve the Treasurer's Report, Joyce Ingram seconded, the motion carried.

Pastor's Report

- During the June 1st Virginia Regional Assembly, Scott attended worship services and two workshops: one on the role of elders and one on having a vision for the church
- There will be a Disciples Women's Retreat at the 4-H Center at Smith Mountain Lake, October 11-13
- Father's Day We will have chocolates for all fathers and a candy bar for special recognitions: oldest father, youngest father, and father with the most children and grandchildren in attendance.
- Attendance plans have changed and Scott will be here during all the Sundays in June, but I will be out of the office during the week following June 23rd
- Laurynn Ballinger is planning to attend Nature Camp at Craig Springs in June. The Church policy is to sponsor 50% of the camp fee of any child that wants to attend the Craig Springs Camp and Retreat Center, which is owned and operated by the Disciples of Christ in Virginia. Bud made a motion to pay 50% of Laurynn's camp fee, Doug Purdue seconded, the motion carried.
- Homecoming July 14th
 - Clean up Day Saturday, July 13th
 - Service will be at 10:00 with Spirtualaires and potluck following
 - Pastor Scott will invite Bill Oliver to be the guest speaker
- VBS Sunday July 14 20
 - Friday 19 Saturday 20 the church will be open for teachers to set up
 - Looking for large refrigerator/washer & dryer boxes for VBS projects
 - Looking for volunteers to serve as crew leaders and to prepare meals
- Due to the special events in July, Bud made a motion to cancel the July Board meeting, Vivian seconded, the motion carried

Committee Reports

• Property

- There is a board rotting out next to the playground the bottom board and needs to be replaced.
- The door downstairs looks like it's pulling the frame out. Adam Eller said he will look at the door and see if he can repair it.
- Mulch should be delivered tomorrow and will be billed to the church.

Old business

- VBS See Pastor's Report
- Roof The final cost was \$1,000 more than the estimate, which was less than the \$5,000 we anticipated. This was for additional plywood and repair of the drop ceiling where materials had fallen through in the vestibule by the Fellowship Hall.

New Business

- Parsonage Rent We've been charging \$900/month for the past five years. With the insurance increase, it's time to consider increasing the rent. It's difficult to find comparable rents in the Snow Creek area. The average rent in the Roanoke area is \$1,700/month, and in Martinsville and Rocky Mounts it is \$1,200/month. Bud made a motion to increase the parsonage rent by \$100, from \$900 to \$1,000 per month, Vivian seconded, the motion passed.
- Kitchen Supplies and Cleaning Supplies Joyce will email GB with what is needed and GB will coordinate with Veronica Doyle and Debbie Haynes to order the supplies.
- Steeple To replace the steeple with a new one will cost between \$10,000-15,000. If we can find someone who can wet sand the old steeple, and then prime and paint it, it may be possible to return the old steeple to the church. Regardless of which option for replacing the steeple, we'll need a crane and bucket truck and Davis Construction here to make sure it's properly secured to the roof. Bud made a motion to determine if it is feasible to refurbish the old steeple, Vivian seconded, the motion carried.
- Internet service for the church -
 - B2X is the current service, downtime has improved, but video calls, upload and downloads are not possible
 - Starlink is an option that can be installed without damaging the roof since they use a saddle mount. \$700 installation cost / \$120 monthly cost
 - River Street –Fiber internet connection is coming to the area from this group, but it is three-four years out. Part of this time frame is related to the railroads granting ISPs the right to cross their tracks.



The Christian Church (Disciples of Christ) in the United States and Canada grew out of two movements seeking Christian unity that sprang up almost simultaneously in western Pennsylvania and Kentucky – movements that were backlashes against the rigid denominationalism of the early 1800s.

Thomas and Alexander Campbell, a Presbyterian Scotch-Irish immigrant father and son in Pennsylvania, rebelled against the dogmatic sectarianism that kept members of different denominations – and even factions within the same denomination – from partaking of the Lord's Supper together. Walter Scott, an immigrant from Scotland, was a successful evangelist of the resulting Campbell movement as it separated from the Baptists.

Barton Stone

Barton W. Stone, a fifth-generation American in Kentucky and also a Presbyterian, objected to the use of creeds as tests of "fellowship" within the church, which were a cause of disunity, especially at the Lord's table. He was a key participant in the **Restoration Move-**

ment following the Cane Ridge Revival of 1801 near Paris, KY.

"Christians," the name adopted by Stone's movement, represented what he felt to be a shedding of denominational labels in favor of a scriptural and inclusive term. Campbell had similar reasons for settling on "Disciples of Christ" but he felt the term "Disciples" less presumptuous than "Christians." (For an introduction to some of their ideas, see the Last Will and Testament of the Springfield Presbytery – 1804 or the Declaration and Address – 1809.)


The aims and practices of the two groups were similar, and the Campbell and Stone movements united in 1832 in Lexington, KY after about a quarter of a century of separate development. (For key dates and more detail, go to the Disciples of Christ Historical Society website.)

The founders of the Christian Church hoped to restore Christian unity by returning to New Testament faith and practices. But the church found that even this led to division. One group which opposed practices not specifically authorized by the New Testament, such as instrumental music in the church and organized missionary activity, gradually pulled away. That group finally was listed separately in the 1906 federal religious census as the "Churches of Christ."

Another group began a separation in 1926 over what it felt were too-liberal policies on the mission field in the practice of baptism. More than 40 years later (1967-69) some 3,000 of those congregations formally withdrew at the time of Disciples restructure. They refer to themselves as the Christian Churches/Churches of Christ.

The tapestry of today

The Christian Church (Disciples of Christ) is a *North American* denomination. North America has long been racially and culturally diverse but church life is not always integrated. The Christian Church (Disciples of Christ) participates in the racial and cultural diversity of North America, including in its membership European Americans, African Americans, Hispanic Americans and Pacific Island/Asian Americans. Disciples are working to become a pro-reconciling anti-racist church. We also have brothers and sisters in Canada who joined our movement with a slightly different history.
